**ORDER NO. A5/3412/17 Dated: 21.06.2018**

The under mentioned Primary teacher of this District are provisionally promoted as primary HMs with immediate effect according to the seniority, qualification and eligibility against the existing vacancies under Rule 31(a) 1958. The heads of school will relieve the promotees only after verifying their date of birth, qualification including training and departmental test qualification eligibility for test exemption under the 5<sup>th</sup> proviso to Rule 13 B of Kerala State Subordinate Service Rule and Govt. Order No.(2) read above. In the case of promotees who are found unqualified or under qualified or promotion to the cadre of Headmasters/Headmistress of Departmental primary school he/she should not be relieved and that fact be reported to this office for rectification of the discrepancies.

The P.D.Teachers under order of promotion are free to relinquish their right for promotion under Rule 31 (a) 1958 Read with the provision contemplated in GO(P)No.39/91 P&ARD dtd.07.12.91 either permanently or temporarily. Temporary relinquishment shall be for a minimum period of one year. Temporary relinquishment of the right of promotion will be allowed only once in service and temporary relinquishment if any tendered for the second time will become absolute and permanent. In the case of promotee desires to relinquish his/her right of promotion to the cadre of Departmental Primary School Headmaster/Headmistress , he/she should apply in the format for the statement of relinquishment annexed to GO(P)No.39/91 P&ARD dtd.07.12.91 to the Deputy Director of Education, Ernakulam through the controlling officers concerned within seven days on receipt of this order.

All the persons under order of promotion and transfer should be relieved **on or before 28/06/18** only by the heads of schools with the direction to join new station forth with. If the promotees have been transferred from the school mentioned in this order, the HMs concerned should forward this order to their present school.

The date of relief and admission to duty of the persons should be reported to this office as well as the controlling officers concerned in due course. The P.D.Teachers/HSA on promotion are posted as HMs in the school noted against their names hereunder.
